#### **DECLARATORY RULING**

THIS MATTER having come to be heard upon the specific request of Anheuser-Busch Inc, CITY Beverage – Illinois Inc and their affiliates, this Commission having heard the argument of counsel, and being otherwise fully informed does hereby declare:

#### Statement of Facts

- 1. Anheuser Busch Inc ("AB Inc") is a duly licensed Illinois Non-resident Dealer.
- CITY Beverage Illinois, Inc. ("CITY Beverage") is a parent company of CITY Beverage –
  Chicago, CITY Beverage LLC, and CITY Beverage Markham LLC, each duly-licensed Illinois
  Distributors and Importing Distributors.
- 3. AB Inc. is the owner of affiliate Wholesaler Equity Development Corporation ("WEDCO").
- AB Inc. has proposed to purchase through its affiliate WEDCO, a 70% interest in CITY Beverage.
- WEDCO currently owns a 30% interest in CITY Beverage and has held such an interest since 2005.
- 6. CITY Beverage was issued Illinois distributor licenses from 2005-2009 while WEDCO was, in fact, a 30% owner of CITY Beverage.

#### IT IS HEREBY DECLARED:

- Preserving Illinois' three tier distribution system of alcoholic liquor is a fundamental objective of the Liquor Control Act and the Illinois legislature for reasons of public policy.
- 2 The three tier distribution system supports state interests in liquor tax collection, the maintenance of an orderly market, and the protection of the public against unsafe alcoholic liquor.
- The three tier system further protects against vertical monopolies and economies of scale that would lead to the introduction of cheap alcoholic liquor into the marketplace. In this way, the three tier system promotes temperance and assists in the control and limitation of the irresponsible consumption of alcoholic liquor as required by the Liquor Control Act.

- 4 The Liquor Control Act defines a Distributor and Importing Distributor as a person "other than a non-resident dealer." 235 ILCS 5/1-3.15, 235 ILCS 5/1-3.16.
- 5 The Liquor Control Act does not specifically allow a Non-resident Dealer to also be a Distributor.
- 6 In this case, Anheuser-Busch Inc., a Non-resident Dealer and through its affiliate, WEDCO, has held a 30% interest in CITY Beverage since 2005.

### Therefore, the Illinois Liquor Control Commission DECLARES:

A. Based on the law, AB Inc., and its affiliates are currently on notice that the Liquor Control Act prohibits an Illinois licensed Non-resident Dealer from possessing an ownership interest in a licensed Illinois distributor. If CITY Beverage should notify the Illinois Liquor Control Commission per ILCC Rule 100.100 that AB Inc, WEDCO or any of its affiliates has purchased any additional interest in CITY Beverage, then the ILCC will consider CITY Beverage licenses to be held in violation of the Liquor Control Act and the licenses will be subject to revocation or refused renewal.

This factual determination is limited solely to the history and facts surrounding this case and will have no bearing on future legal declarations or rulings of the Illinois Liquor Control Commission.
