Educational Sessions

21st Amendment and Supreme Court Roundup

This panel will address recent alcohol-related litigation around the country as well as highlight important U.S. Supreme Court decisions that could impact states.

Developments in Franchise Law

This panel will address recent actions related to the relationships between alcohol suppliers and alcohol distributors, and it will highlight potential future activities in this important area of alcohol codes.

Age Verification and Alcohol

The U.S. Supreme Court, several circuit courts and many state legislatures have addressed issues related to age verification. This panel will explore several cases in this field and offer the perspectives of state alcohol regulators and a state solicitor general.

Controversial Alcoholic Drinks: Past, Present and Future

Recent news headlines have brought renewed attention to some controversial alcoholic products. The debate over which alcoholic products should or should not be sold – from grain alcohol to large containers to high alcohol products – is generating discussion about industry responsibility and the role of state and federal regulations.

Law Enforcement's Role in Alcohol Policy

National surveys indicate that public safety is one of the most important issues influencing alcohol policy decisions and enforcement. In both control and licensing states, however, new pressures are challenging current alcohol regulation and taxing regulatory resources. This panel will explore the radically changing demands of alcohol regulation and alcohol law enforcement.

Privatization of State-Run Alcohol Systems

Recent efforts to remove state governments from existing sale and distribution functions have generated attention in both the media and at the ballot box. Many of these state systems fuel significant revenue streams in addition to regulating the industry. This session will explore the privatization debate from various perspectives, including public health, state regulators and industry.

324 Liquor & Midcal: What Do They Really Mean?

State alcohol laws tend to attract Supreme Court antitrust jurisprudence; the specific details of these cases, however, often are very unique. The federal government both notes the importance of alcohol pricing restrictions for public health considerations while also discouraging pricing restrictions because of antitrust factors. This session will examine two cases from 25 years ago and their relevance today.

Hot Topics in Litigation and Regulation

This panel will explore a wide variety of issues and challenges facing state alcohol regulators and attorneys, from budget pressures to understanding which proposed laws would be subject to legal challenge. Hear from experts in the field as they discuss issues their states have been facing in 2011.

Diverse Stakeholders Confronting Alcohol Policy

Often alcohol policy debates involve similar organizations airing their perspectives. This session will highlight additional stakeholders in alcohol policy debates, why they are interested in this subject and what they see as challenges and opportunities on the horizon.

The Timeless Importance of *Toward Liquor Control*

In 1933, John D. Rockefeller, Jr. commissioned Raymond B. Fosdick and Albert L. Scott to study alcohol regulation and prepare America for the return of legal alcohol and its regulation following the passage of the 21st Amendment which ended Prohibition. This panel will discuss how *Toward Liquor Control* provided guidance to policymakers as they set up regulatory systems for alcohol and the extent to which that framework still exists today.

The Honorable Rob McKenna, *Washington Attorney General and President, National Association of Attorneys General*

The role of the attorney general in upholding a state's alcohol laws continues to be a key focus of alcohol policy debates. Attorney General McKenna will reflect on issues including the role state attorneys general play in policy debates about alcohol; a state's role under the 21st Amendment; society's interest in fighting the abuse of alcohol, underage drinking and crime; and protecting small businesses and consumers.
